

Impact on Students

Launched the Antiracism Programming Initiative to create 10 programs for grades K-8 aimed at communicating principles of antiracism, uplifting Black art-making traditions, and celebrating Black joy. Programs serve students, teachers, and families.

Communications

Developed our Identity First Statement to guide language to dismantle disableism. We respectfully use *Disabled artists* and *Disabled students* to support Disability justice, equity, and inclusion in the arts.

Organizational Accountability

Improved salary transparency that resulted in a new "salary band" policy incorporated in the employee handbook and shared with job candidates.

Continuous Learning

The Arts United board committee led trustees in a learning session around Ibram X. Kendi's *Stamped from the Beginning: The Definitive History of Racist Ideas in America.* **14,711** children **181** schools **8,327** educators

Healing

This year we focused on the intersections of social emotional learning, creative practice, and mindfulness. Students learned how creative writing, poetry, and music offer opportunities to understand and practice strategies for rest, relaxation, and managing emotional states. 

Teaching artists reimagined opportunities for students to explore science and other subjects through music and movement. Results:

STUDENTS

- 88% increase in comfort level in asking questions about Muslim people and culture
- 79% increase in the "strongly agree" category to the statement "I can be friendly to people who are different from me"
- 67% increase in who agreed or strongly agreed that Muslims are treated unfairly because of what they believe

TEACHERS

- 121% increase in the "Agree" category when asked if they feel equipped to begin implementing strategies in the classroom that value Muslim culture and experience
- 205% increase in confidence level in understanding Muslim culture
- 87% increase in who felt they can identify their biases against Muslims

Creative Adaptations

During the COVID-19 pandemic, working outdoors has become a necessity for our work with children. Teaching artist Marilyn Keating led students in an outdoor sculpture residency that included brainstorming, sketches, mockup models and ended with building life-sized sculptures. These sculptures enhanced the beauty of the school's outdoor classroom and allowed students to explore their imaginations as they collaborated with classmates to bring their unique creatures and creations to life.


